DEAR MR. REIMERS :

COMPANY HAS RECENTLY CHANGED THE DEMARCATION OF FISCAL PERIOD SO THAT EACH FISCAL PERIOD COVERS APRIL TO SEPTEMBER AND OCTOBER TO MARCH OF THE NEXT YEAR.
